

输华葡萄酒装运前检验报检须知

Instruction for Wine Export to China Pre-shipment Inspection

澳大利亚葡萄酒出口中国前,申请人向中国检验认证集团澳大利亚有限公司(CCIC AUSTRALIA PTY LTD)提出检验申请,具体程序如下:

Before exporting Australian wines to China, applicants shall apply to CCIC Australia Pty Ltd for inspection following the procedures:

1、申请检验 Application

初次申请时,申请人应首先填写《输华葡萄酒信息服务系统用户申请单》,扫描后以邮件方式发至我司 (marketing@ccicaus.com)。经审查后, CCIC Australia会发出用户名和密码。申请人根据需求(原产 地溯源证书、标签预审核证书、品质预检验证书),在PSI系统上提交申请(域名是psi.ccicaus.com)。 详情请参考《输华葡萄酒信息服务系统发货商使用说明书》。

First time applicants shall fill in PSI System User Application Form and email it to our marketing department (marketing@ccicaus.com). A confirmation of user name and password will be assigned after verification. The applicant submits their application online at psi.ccicaus.com for Certificate of Origin Traceability, Certificate of Pre-shipment Label Approval or Certificate of Pre-shipment Quality Approval. For details, please refer to Information Service System for Wine Export to China User Manual.

2、检验申请的处理 Document Verification

CCIC Australia 收到检验申请后,将在2个工作日内审核申请人提交的文件资料是否符合要求。审核完 毕后,会在系统内确认接受申请。申请人电话咨询时,请报告公司名称以及申请编号。

Acceptance of application and the verification process normally takes 2 working days. A confirmation notice shall be issued after this process. For inquiries, please provide your company name and your reference number.

3、检验 Inspection

客户申请标签预审核或品质预检验时,需按要求提供酒样给 CCIC 澳洲公司。检测时间需要 7 个工作日。 The applicant shall provide CCIC Australia wine samples for pre-shipment label approval or quality inspection. Inspection normally takes 7 working days.

4、申请监装 Application for Loading Supervision

CCIC Australia 将根据客户申请派员到现场监装,并与申请人商定具体的日期和准备事项。为了能确保 检验工作的顺利进行,申请人需提前7个工作日提出申请。

After acceptance of application, CCIC Australia shall send inspector out for loading supervision. The applicant shall submit their application 7 days before an inspection date can be arranged.

5、证书的签发 Issue of Certificate

审核和检验完毕后,CCIC Australia 将在 3 工作日内签发证书。证书一正二副将以邮件寄送给申请人, 申请人(或其代理人)持 CCIC Australia 检验证书到口岸 CIQ 办理相关手续。

After verification and inspection, CCIC Australia shall issue certificates in 3 working days. One original and two copies shall be sent to the applicant for use in destination ports.
